AFFILIATE PROGRAMME — COMMERCIAL TERMS

Updated as at 9 Sept 2026

1. Application of Commercial Terms

These Commercial Terms are issued pursuant to the PakaiDulu Affiliate Programme Agreement (the "Agreement") and form an integral part thereof. Capitalised terms used but not defined herein shall have the meanings ascribed to them in the Agreement.

These Commercial Terms set out the commission structure applicable to the Affiliate's participation in the PakaiDulu Affiliate Programme and shall take effect upon the Affiliate's written acceptance of these terms following approval of registration.

2. Commission Structure

The Affiliate shall be entitled to earn commission per eligible referral in accordance with the following schedule, subject always to the conditions set out in Clause 3 below:

3. Commission Conditions

Commission shall only be earned and become payable where all of the following conditions are satisfied:

- The customer's application has been successfully submitted through the designated PakaiDulu channel;
- The application has been reviewed and approved by DirectD; and
- The applicant has completed the collection of the device.

No commission shall be payable in respect of any referral that does not fulfil all three (3) conditions above.

4. Payment of Commission

Commission payments shall be processed on the following schedule: (i) the monthly commission cut-off date is the 5th of each calendar month, capturing all eligible referrals where device collection was completed on or before the 5th; and (ii) commission payable for that month shall be disbursed on or before the 15th of the same calendar month. Payment shall be made via bank transfer to the Affiliate's registered bank account. The Affiliate is responsible for ensuring that accurate and up-to-date banking details are maintained on record with DirectD. Eligible referrals completed after the 5th of any given month shall be carried forward to the following month's commission cycle.

DirectD reserves the right to withhold or set off any commission payment where there is a reasonable basis to suspect fraud, misrepresentation, or breach of the Agreement by the Affiliate.

5. Amendments

DirectD reserves the right to amend these Commercial Terms at any time. Continued participation in the Programme following the effective date of any amendment shall constitute the Affiliate's acceptance of the revised Commercial Terms.

6. Acceptance

By accepting these Commercial Terms (whether by electronic confirmation, email reply, or continued participation in the Programme following receipt), the Affiliate confirms that they have read, understood, and agree to be bound by these Commercial Terms, which together with the Agreement constitute the entire understanding between the parties in respect of the PakaiDulu Affiliate Programme.

1. Pemakaian Terma Komersial

3. Syarat-Syarat Komisen

4. Pembayaran Komisen

Pembayaran komisen akan diproses mengikut jadual berikut: (i) tarikh penutupan komisen bulanan adalah pada hari ke-5 setiap bulan kalendar, merangkumi semua rujukan layak di mana pengambilan peranti telah diselesaikan pada atau sebelum hari ke-5; dan (ii) komisen yang kena dibayar bagi bulan tersebut akan diagihkan pada atau sebelum hari ke-15 bulan kalendar yang sama. Pembayaran akan dibuat melalui pindahan bank ke akaun bank berdaftar Affiliate. Affiliate bertanggungjawab memastikan maklumat perbankan yang tepat dan terkini direkodkan bersama DirectD. Rujukan layak yang diselesaikan selepas hari ke-5 mana-mana bulan akan dibawa ke hadapan ke kitaran komisen bulan berikutnya.

DirectD berhak menahan atau menolak sebarang pembayaran komisen sekiranya terdapat asas munasabah untuk mengesyaki penipuan, salah nyata, atau pelanggaran Perjanjian oleh Affiliate.

5. Pindaan

DirectD berhak meminda Terma Komersial ini pada bila-bila masa. Penyertaan berterusan dalam Program selepas tarikh berkuat kuasa sebarang pindaan hendaklah merupakan penerimaan Affiliate terhadap Terma Komersial yang dipinda.

6. Penerimaan

Dengan menerima Terma Komersial ini (sama ada melalui pengesahan elektronik, balasan e-mel, atau penyertaan berterusan dalam Program selepas penerimaannya), Affiliate mengesahkan bahawa mereka telah membaca, memahami, dan bersetuju untuk terikat dengan Terma Komersial ini, yang bersama-sama dengan Perjanjian merupakan keseluruhan persefahaman antara pihak-pihak berkenaan Program Affiliate PakaiDulu.
